On July 25th Attorney John A. Felix hosted a Lunch and Learn titled, "To Commit or Not Commit? That is the Mental Health Question." The LCPA has received lots of positive feedback with respect to this well attended event. Attorney Felix has been a hearing officer on the Mental Health Review Board for thirty five years. He spoke about the process for involuntary mental health committals.

Attendees learned about the standards for involuntary commitments, the timeframes that the law requires hearings to be held and the amount of time a person can be ordered to be committed to a mental hospital/ward.

At this lunch and learn attendees also learned about voluntary committals and committals (and other non-committal options) for juveniles.

Attorney Felix was an engaging speaker and the LCPA is grateful for his willingness to host a Lunch and Learn.

On September 5th Attorney Marc S. Drier hosted a Lunch and Learn titled, "Boundaries and Rights of Way." The event was well attended by local attorneys and paralegals. Topics discussed included adverse possession, consentable boundaries, the "Bundle of Rights" theory, various types of easements, condemnation and potential changes in the law. Attorney Drier is truly an authority on this legal subject.

Attorney Drier was a very knowledgeable and approachable host. After discussing the different boundary issues and addressing various legal theories and pending cases before Superior Court, Attorney Drier answered lots of questions from the lawyers and paralegals seeking his advice.
