

The Criminal Process from Incident to Sentencing

On March 13<sup>th</sup> Attorney Ron Travis hosted a Lunch and Learn about jury selection in capital cases commonly called "The Colorado Method." The approach, which is being utilized in many death penalty federal cases, is a method by which a defense attorney categorizes potential jury members according to their stance on capital punishment. This method, which essentially embraces the prosecution's evidence instead of trying to exclude it, helps to inform jury members to the heinousness of the crime at the jury selection stage and assists the defense in isolating and striking jury members who are extremely favorable to sentences of death.

Attorney Travis is a very knowledgeable and captivating speaker. Indeed, many of the paralegals and lawyers in attendance have commented that they would have enjoyed listening to Attorney Travis speak all day about this topic.
