

# 2017 PENNSYLVANIA HIGH SCHOOL MOCK TRIAL COMPETITION

In January, February, and March, high school students statewide participated in the Mock Trial Competition at the Federal Courthouse in Williamsport. This year the trials were criminal cases; last year they were civil cases. The students are required to follow the Rules of Conduct and Rules of Evidence. The trial is held before an actual judge and the students conduct themselves just like real attorneys in the courtroom. Many of the students' presentations this year were very impressive.

The trials usually last 2-3 hours. Jurors are asked to score the students and choose the winning team. Local attorneys, paralegals, and paralegal students are needed to serve as mock jurors for these competitions. Please consider volunteering to serve as a juror for the 2018 Mock Trial Competition.

## Recent CLE Events:

### Thank you for hosting a Lunch & Learn!

On January 25<sup>th</sup>, Geoffrey MacArthur, Assistant U.S. Attorney, hosted a Lunch and Learn event titled "Introduction to the Federal Judicial System.

Geoff began with an overview of the U.S. Attorney's Office and went over the steps in a criminal proceeding within the federal system. He explained that the federal government has limited jurisdiction and gave some examples of cases in which the federal government would have an interest, such as a crime occurring on federal land. As far as sentencing, Geoff explained that a federal sentence is ultimately up to the judge.

The Lycoming County Paralegal Association sponsored a Lunch and Learn event on Wednesday, March 22, 2017 reviewing changes made to the Orphans Court Rules. The presenters were Attorney James G. Malee of *Malee Law Firm, P.C.* and Attorney Susan Roinick, Law Clerk to President Judge Nancy L. Butts of the Lycoming County Court of Common Pleas. Attorney Malee and Attorney Roinick highlighted some of the most significant changes to the rules and what local attorneys and paralegals should consider before filing a petition to the Orphans Court.

Attorneys Malee and Roinick cautioned that some of the new rules are unclear or conflicting. For instance, under Chapter VIII, Reconsideration, the timeline for a Motion to Reconsider and appeal conflict with one another and it may be best to file both in order to secure the appeal request within the 30-day limit. Additional attention was given to completing the new Orphans Court Motions Cover Page, notice, and service section.
